By using our Burrachos web site, you consent to the collection and use of information in the manner described.

How Burrachos uses the information you give us

Burrachos only obtains information, such as your name and e-mail address, when you provide it voluntarily. Burrachos uses its best efforts to protect this information and the privacy of its customers. For example, personal information may be collected from you to:

- respond to your comments regarding a Burrachos restaurant or our website;
 - respond to job inquiries and job applications submitted by you;
 - respond to information submitted by you;
 - add you to our e-mail list or provide e-mails to you as requested (this may be once monthly);

- contact you via phone to discuss the investment opportunity or franchise possibility.

Sharing of personal information

We keep your job inquiries and job applications confidential. However, Burrachos may share personal information within the company and with its affiliated companies as needed to complete an application process. Occasionally, with your permission of course, we will send marketing information to you, such as discount coupons, information about new product offerings, etc. You may ask to be removed from any of these listings at any time!

Burrachos sometimes contacts other companies for a variety of reasons, such as fulfilling orders, assisting with promotions, and providing technical services for our website. These companies may have access to personal information if they need it to do their work. These companies are asked by Burrachos to agree to hold any and all information they may see or manage in their job assignments as confidential.

Burrachos will not sell, transfer or disclose your personal information to any third parties.

Burrachos reserves the right to use or disclose any information as needed to satisfy any law, regulation or legal request, to fulfill your requests, or to cooperate in any law enforcement investigation or an investigation on a matter of public safety. We also may disclose your personal

information when otherwise permitted by applicable privacy laws such as, for example when disclosure is needed to enforce our rights arising out of any agreement, transaction or relationship with you.

Minors (usually those under legal age of majority - 18 - but we're really thinking of those under 13)

Burrachos is very sensitive to privacy issues regarding minors. At this time, however, our website does not request age-identifying information and is not directed at collecting personal information from minors. Parents must regularly monitor and supervise their children's on-line activities. Also, if you need to see any personal information your minor child has given to us or you want it removed from our database, please send us a letter or submit a request for us to address and follow up with you.

Obtaining the personal information you sent us

You are in control of any personal information you give us. If at any time, you want to correct the personal information we have about you, or if you want to change your preferences for contacts from us or on behalf of our business partners, send us an e-mail or a letter. Parents, please see the paragraph above concerning minor children.

Internet security

Burrachos uses "cookies" for a variety of purposes to improve your visits to our website! This information is transferred from our site to the hard drive on your computer for record-keeping purposes. These cookies will allow the website to remember important information that will make your use of the website more convenient. This information may transfer data about a total number of visitors or to remember you when you return to the website; this is not an all-inclusive list.
